Environmental Policy

Wyncoast Industrial Park Public Company Limited and its Subsidiaries

Wyncoast Industrial Park Public Company Limited and its subsidiaries (“Company”) have been aware the importance of the environment and determined to take action on reducing environmental impacts arising from the business operations of the Company and its subsidiaries in all manners. Therefore, the Board of Director has formulated an environmental management policy for efficient usage within the organization in order to reduce environmental impact in every way for achieving the goal and conforming to the intention for development its organization’s sustainable growth upon the guideline of environmental responsibility as follows:

Environmental Management Practices

1. Comply with all laws, regulations, requirements, policies, guidelines, and standards related to resource and environmental management.
2. Promote, develop, and improve environmentally friendly business processes, encompassing design, production, procurement, service, transportation, management, and related activities for continuous efficiency, while consistently delivering high-quality and environmentally friendly products and services to customers.
3. Continuously prevent, control, and mitigate the environmental impacts of business operations on stakeholders throughout the supply chain.
4. Conserve and use energy and natural resources efficiently and effectively, and manage the environment systematically using the 3RS principle (Reduce, Reuse, Recycle).
5. Consider investing in environmentally friendly and energy-efficient businesses or projects, and support environmentally friendly products and services.
6. Manage water sustainably to efficiently and effectively utilize water resources, reducing the use of raw water from natural sources by maximizing the utilization of treated water.
7. Address climate change to reduce greenhouse gas emissions and mitigate its impacts by promoting and supporting the efficient and effective use of electricity, reducing the use of fossil fuels, promoting the development of renewable energy sources, and integrating renewable energy into work processes.
8. Continuously and systematically monitor, inspect, and control environmental quality, and continuously improve operational efficiency. Promote environmental management practices within the industrial estate based on environmental governance principles.
9. Continuously develop the environmental management system by comparing the company's operational efficiency with international standards to enhance and improve environmental management capabilities.
10. Supervise and support business partners, suppliers, contractors/subcontractors, and relevant stakeholders to conduct business in accordance with policies, maintain environmental management standards, and comply with laws. Promote the optimal use of resources and enhance the potential for environmentally friendly business practices.
11. Provide resources and participate in the development of the company's environmental management operations in collaboration with private sector organizations, government agencies, civil society organizations, and local communities.

12. Continuously communicate and promote environmental management awareness among employees, suppliers, business partners, and relevant stakeholders.

Reducing Greenhouse Gas Emissions Practices

1. Promote and encourage all business units to improve energy efficiency within their organizations, reduce both direct and indirect greenhouse gas emissions, and use natural resources wisely.
2. Control and monitor business operations to ensure that greenhouse gas emissions are at levels stipulated by relevant laws and regulations, by increasing the proportion of renewable and clean energy use.
3. Develop or apply technologies and innovations in business operations, including finding safe and environmentally friendly alternative energy sources, to reduce overall energy consumption and greenhouse gas emissions.

Water Resource Management Practices

The Company prioritizes integrated water management to maximize the utilization of raw and recycled water within the company for the benefit of all stakeholders. Therefore, the Company has established the following practices.

1. Comply with all laws, regulations, requirements, policies, guidelines, and standards related to water resource management and wastewater management.
2. Protect and conserve water resources and manage water efficiently throughout the supply chain, minimizing negative impacts of business operations on natural water sources.
3. Set long-term water efficiency targets and promote integrated and efficient water management across all departments.
4. Utilize treated water to its maximum efficiency using the 3RS principle (Reduce, Reuse, Recycle).
5. Maintain sufficient raw water reserves in storage areas both within and outside the company premises to meet consumption needs within the company's operating area and mitigate risks related to water scarcity.
6. Promote and oversee customer, business partner, supplier, and relevant stakeholders to conduct business in accordance with policies and manage wastewater legally and efficiently.
7. Monitor, control, and inspect water quality at all stages to maintain standards.
8. Promote awareness and employee participation in water conservation.
9. Communicate and promote awareness and understanding of sustainable water management to employees, customers, partners, communities, and key stakeholders through training. Sharing knowledge or organizing awareness campaigns in various forms on a continuous basis.

Waste management Practices

1. Comply with all laws, regulations, requirements, policies, guidelines, and standards related to waste management.
2. Oversee and support business partners, suppliers, contractors/subcontractors, and relevant stakeholders to conduct their business in accordance with these standards.

3. Waste management is carried out in a standardized and legally compliant manner, promoting the optimal use of resources and adding value to waste.
4. Manage waste efficiently, reduce waste at its source, minimize waste incineration and unnecessary use of natural resources, by applying the 3RS principle (Reduce, Reuse, Recycle).
5. Promote the participation and development of waste management capabilities among direct stakeholders, including business partners, contractors/subcontractors, operators in the operating area, and local communities, through various projects and activities to create a model society for sustainable waste management.
6. Continuously communicate and promote awareness of waste management among employees, business partners, suppliers, and relevant stakeholders.
